In selling falsely labeled goods, the party runs the risk of violation of Federal origin labeling laws, Federal and State false advertising laws, and liability to the purchaser of the products under theories of fraud and violations of California Civil Code. FEDERAL LAW - COUNTRY OF ORIGIN LABELING

What information should be included in an unlabeled container?

All of the above. Pictograms and signal words. Hazard and precautionary statements. Product identifier and supplier information. How do I know if a product is compatible with a voltage source?

To determine (before installation) the compatibility between the product and the voltage source, the product maximum current(or power) is marked on the product. In some jurisdictions, and for some installations, the product current cannot exceed 80% of the voltage source current rating.
