

# Exporting photovoltaic modules to the EU

Are solar panels imported or manufactured in the European Union?

Solar panels imported or manufactured in the European Union are subject to various regulations, directives and standards. Ensuring compliance requires that the solar panels meet certain technical requirements. In addition, solar panels must be correctly labelled, documented, and tested.

What was the EU export value of solar panels in 2023?

The EU import values of solar panels and liquid biofuels in 2023 were much higher than the corresponding EU export values which were EUR0.9 billion for solar panels and EUR2.2 billion for liquid biofuels. By contrast, the EU export value of wind turbines in 2023 (EUR2.0 billion) was much higher than the corresponding value for imports.

Which country imports the most PV modules to Europe?
