



The latest energy storage standards for new energy power stations

What are the new standards for energy storage in Canada?

The Canadian Standards Association (CSA) has issued the new standard for Distributed Energy Resources (DER). These new standards have an impact on energy storage systems in Canada.

What is an energy storage system (ESS)?

Covers an energy storage system (ESS) that is intended to receive and store energy in some form so that the ESS can provide electrical energy to loads or to the local/area electric power system (EPS) when needed. Electrochemical, chemical, mechanical, and thermal ESS are covered by this Standard.

What is a battery standard?

Covers requirements for battery systems as defined by this standard for use as energy storage for stationary applications such as for PV, wind turbine storage or for UPS, etc. applications.

What is a battery management standard?

A new standard that will apply to the design, performance, and safety of battery management systems. It includes use in several application areas, including stationary batteries installed in local energy storage, smart grids and auxiliary power systems, as well as mobile batteries used in electric vehicles (EV), rail transport and aeronautics.
